There will be a City of Grandview Heights Regular Council meeting on Monday, December 6, 2021 at 7:00 p.m. at the Grandview Center, 1515 W. Goodale Blvd. Please enter only through the main door and exit the building using the door at the back of the meeting room.

“COVID-19 Update: The safety of our residents, employees and public officials remains our top priority. Masks are REQUIRED inside the building. Social distancing will be practiced. Council is allowing in-person comments from visitors. Such comments shall be directed to the President and should not take the form of colloquy or debate with members of Council or Administration. All persons making comments will complete a Speaker Request form and shall state their name and address when called to speak.

Meetings are recorded and are posted on the City’s website. Persons who wish to provide comments, but prefer not to attend in-person, can submit a Request for Public Comment form NO LATER THAN NOON the day of the Council meeting. The commenter’s name, address and subject of comments will be read into the public record. A full copy of the form will be attached to the meeting minutes once adopted. Any comments received after NOON the day of the meeting will be held until the next public meeting.
