1. Res. 17-2023: A Resolution adopting a tax budget for fiscal year 2024. 3rd Reading. Not assigned.
 2. Ord. 2023-01 (2022-11): An Ordinance to authorize the City of Grandview Heights to establish an opt-out governmental electric aggregation program for residential and non-mercantile consumers located within the incorporated areas of the City of Grandview Heights, to direct the Franklin County Board of Elections to submit the ballot question to the City’s electors on the November 8, 2022 ballot, and declaring an emergency. 4th Reading. 4. Ord. 2023-18: An Ordinance to approve supplemental appropriations for the City of Grandview Heights Building Department for the fiscal year ending December 31, 2023. 2nd Reading. Assigned to Finance.

Ord. 2023-19: An Ordinance to amend the Zoning Plan and Map of the City of Grandview Heights by changing the zoning classification of certain parcels within the City of Grandview Heights, Ohio from various classifications to C-1, Limited Commercial District. 2nd Reading. Assigned to Planning & Administration.
