1. Ord. 2023-23: An Ordinance to amend Codified Ordinance 161.02 of the City of Grandview Heights, Ohio, to reflect increased public-works bidding levels authorized by state law. 2nd Reading. Not assigned.
 2. Ord. 2023-24: An Ordinance to approve supplemental appropriations for the City of Grandview Heights for the fiscal year ending December 31, 2023. 2nd Reading. Assigned to Finance.
 3. Ord. 2023-25: An Ordinance to dedicate approximately 3'-0' or 0.028 acres of real property along the eastern edge of parcel 030-000281, owned by the City of Grandview Heights, to public right-of-way, for purpose of facilitating improvements to Glendale Avenue related to the construction of the City's new Fire/EMS, Police, and Administrative Services Facility, and declaring it an emergency. 2nd Reading. Assigned to Recreation & Public Facilities.

4. Ord. 2023-26: An Ordinance to vacate a portion of previously unimproved right-of-way adjacent to McKinley Field Park, and to consolidate City-owned parcels for public park uses, including the construction of a new Parks and Recreation Facility, and declaring it an emergency. 2nd Reading. Assigned to Planning & Administration.
5. Ord. 2023-27: An Ordinance authorizing the Mayor of the City of Grandview Heights to enter into an agreement with the City of Columbus, Ohio for the provision of certain emergency dispatching services and making appropriations for this essential service, and declaring an emergency. 2nd Reading. Assigned to Safety.
